All of our alloying products have been pre-registered under REACH and will be subject to full registration by our suppliers, or will be registered by our company in terms.
2. Products that Walcownia Metali "Dzierdzice" S.A. provides to your company are brass products with a specific chemical composition consistent with the relevant standard or with a composition recommended in the order.

According to article 31 of REACH, products delivered to your company do not require Safety Data Sheets.
3. Our products are free of substances classified as CMR, PBT or vPvB.
4. We inform that lead is on the SVHC substance list.
5. The content of the substances listed in Directive 2002/95 / EC (RoHS) and 2011/65 / EU, and which may be present in the products manufactured by the Company is as follows:

- Lead - as an alloying element of copper alloys, the Annex to Directive 2002/95/ EC allows usage up to 4%
- Cadmium, hexavalent chromium and lead - the European Commission Decision No. 2005/618 / EC of 18.08.2005 - Article 1 adds to the Annex to Directive 2002/95/EC, that it is permitted to use up to 0.1% by weight of
