Concerns: obligation of providing information about harmful substances contained in Products manufactured in Walcownia Metali „Dzierdzice” S.A.

**Information about harmful substances contained in products and semi products manufactured by Walcownia Metali „Dzierdzice” S.A. acc. to RoHs III Directive no 2015/863 UE.**

Walcownia Metali „Dzierdzice” S.A. with seat in Czechowice-Dzierdzice ul. Kaniowska 3, informs, that none of the manufactured products or semi products contain substances such as:

- Hg – Mercury,**
- PBB – Polybrominated Biphenyls,**
- PBDE – Polybrominated Diphenyl Ethers,**
- DEHP – Bis (2-Ethylhexyl) phthalate,**
- BBP – Benzyl butyl phthalate,**
- DBP – Dibutyl phthalate,**
- DIBP – Diisobutyl phthalate,**

Content of other substances mentioned in the Directive and occurring in goods manufactured by Walcownia Metali „Dzierdzice” S.A. is the following:

- 1) **Pb – lead – up to 4 % occurs in rods, tubes and strips in leaded brass alloys,**
- 2) **Pb – lead – up to 0,1%,**
- 2) **Cd – cadmium – up to 0,01%,**
- 2) **Cr(VI) – hexavalent chromium – up to 0,1%.**

Comments:

- 1) lead -- as a chemical element of leaded brass alloy - Annex III p. 6c to the Directive 2011/65/UE allows to use up to 4 % Pb,
- 2) lead, cadm and hexavalent chromium– Annex II to Directive 2011/65/UE describes max values and their concentration allowed by weight in uniform materials.
